SUPPLY OF GOODS

14.4 Waiver and cumulative reme

- A waiver of any right under the Contract is only effective if it is in writing and shall not be deemed to be a waiver of any subsequent breach or default. No failure or delay by a party in exercising any right or remedy under the Contract or by law shall constitute a waiver of that or any other right or remedy, nor preclude or restrict its further exercise. No single or partial exercise of such right or remedy shall preclude or restrict the further exercise of that or any other right or remedy. Unless specifically provided otherwise, rights arising under the Contract are cumulative and do not exclude rights provided by law. (a)

- If a court or any other competent authority finds that any provision (or part of any provision) of the Contract is invalid, illegal or unenforceable, that provision or part-provision shall, to the extent required, be deemed deleted, and the validity and enforceability of the other provisions of the Contract shall not be affected. If any invalid, unenforceable or illegal provision of the Contract would be valid, enforceable and legal if some part of it were deleted, the provision shall apply with the minimum modification necessary to make it legal, valid and enforceable. - No partnership: Nothing in the Contract is intended to, or shall be deemed to, constitute a partnership or joint 14.6 venture of any kind between any of the parties, nor constitute any party the agent of another party for any purpose. No party shall have authority to act as agent for, or to bind, the other party in any way.
- 14.7 Third parties: Save as otherwise provided herein, a person who is not a party to the Contract shall not have any rights under or in connection with it.
- 14.8 Variation: Any variation, including any additional terms and conditions, to the Contract shall only be binding when agreed in writing and signed by the Customer.
- 14.9 Governing law and jurisdiction: The Contract, and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims), shall be governed by, and construed in accordance with, English law, and the parties irrevocably submit to the exclusive jurisdiction of the courts of England and Wales
- Anti-Bribery: Both parties acknowledge and agree that they will adhere to and comply with the provisions of the Bribery Act 2010 and will have appropriate measures and safeguards in place to comply with this Act. 14.10
- Anti-Slavery: Both parties will comply with all applicable anti-slavery and human trafficking laws, statutes, regulations and codes from time to time in force including but not limited to the Modern Slavery Act 2015, and to maintain during the period of the Contract policies and procedures to ensure compliance therewith.
- Whistleblowing: both parties shall maintain policies encouraging the utmost integrity and honesty in the conduct of business, and such policies shall encourage employees to freely report any suspected wrongdoing in 14.12 the workplace or in the conduct of that party's business.
