What data do we collect?

How do we collect your data?

Cookies

Embedded content from other websites

Articles on this site may include embedded content (for e.g. videos, images, articles, etc.). Embedded content from other websites behave in the exact same way as if the visitor has visited the other website. These websites may collect data about you, use cookies, embed additional third-party tracking, and monitor your interaction with that embedded content, including tracking your interaction with the embedded content if you have an account and are logged in to that website.

IP Address

We also receive IP address and some user information. This information is collected anonymously and is used to better understand how people use our site and improve its performance

How will we use your data?

Bibby Marine collects your data so that we can:

- Contact you regarding your enquiry
- Send you marketing emails about our service for e.g. upcoming vessel availability

How do we store your data?

Data is stored in UK data centres that meet privacy standards, laws and regulations. Further information is available on request.

What are your data protection rights?

Bibby Marine would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access - You have the right to request Bibby Marine for copies of your personal data. We may charge you a small fee for this service.

The right to rectification - You have the right to request that Bibby Marine correct any information you believe is inaccurate. You also have the right to request Bibby Marine to complete information you believe is incomplete.

The right to erasure - You have the right to request that Bibby Marine erase your personal data, under certain conditions.

The right to restrict processing - You have the right to request that Bibby Marine restrict the processing of your personal data, under certain conditions.

The right to object to processing - You have the right to object to Bibby Marine's processing of your personal data, under certain conditions.

The right to data portability - You have the right to request that Bibby Marine transfer the data that we have collected to another organisation, or directly to you, under certain conditions.

If you make a request, we have one month to respond to you. If you would like to exercise any of these rights, please contact us *through our enquiry form*.

What are cookies?

Cookies are text files placed on your computer to collect standard Internet log information and visitor behavior information. When you visit our websites, we may collect information from you automatically through cookies or similar technology.
